Data protection information

Adarvo Ltd agrees to protect the privacy of any person who uses our website and to treat as confidential the personal data that our customers give us. Whenever we are given personal data (registration forms, credit card numbers etc.), we use the latest encryption techniques, «Secure Socket Layer» (SSL) transfers. Which information do we collect?

If you request information, need support or want to download Adarvo ThemeWare, we will require personal information such as your name, address, telephone number, e-mail address and credit card number.

-> Important: Adarvo Ltd does not use «cookies»!

How do we use the information we have gathered?

Adarvo Ltd regularly sends e-mails to its customers to inform them about products, services, events and promotions offered exclusively by Adarvo Ltd. We only analyze the gathered information for our own marketing purposes. We do not pass on the personal data for our customers to others outside Adarvo Ltd.

You can stop our information e-mails at any time by sending us an e-mail.

Log Files

We use the information from the server log file to manage our web site and to monitor the application paths, which are anonymous for us. We then use this data to create detailed demographic statistics about the use of our website. The information in these files contain the IP address of our website visitors, the visited websites, the website from which they jumped to ours and information about which browser they are using. However, none of this information is linked with information that identifies individuals.

Security

Your data and account information are encrypted during data transfer and saved securely on our server. Our customers' data, which is saved or shared in their particular accounts/groups, cannot be viewed by Adarvo Ltd.

Adarvo ThemeWare – password

The security of Adarvo ThemeWare is based on you protecting your password. We recommend that you never tell anyone your password.

Forbidden activities

You are specifically forbidden to use Adarvo ThemeWare to publish material/documents that

- annoy, libel or deceive people
- hurt people's feelings because of their religion, nationality or race
- contain malicious or indecent remarks, hate attacks or threats of violence
- contain obscene materials or pornography
- in any way place children or young people in danger

Consequence of forbidden activities

We retain the right to take drastic steps if we become aware of a matter that might contravene this policy.

Direct marketing

We will regularly send you information about Adarvo ThemeWare (special offers, news) via e-mail. As already mentioned in «How do we use the information we have gathered?», you can stop these e-mails at any time.

We will also send you e-mails about administrative matters. For example, if you do not use your account for six months we will contact you to tell you that we will close your account if you do not use it within the next three months.

Agreement with these guidelines

The prerequisite for your agreement to these guidelines is the integrity, continuity and security of our website and Adarvo Ltd's server-based services.
